High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

On Monday 7 February and Tuesday 8 February 2022 BBV will complete surfacing works to the site entrance of our compound on the Watton Lane, adjacent to Gypsy Lane. This will take two days; the works will include surfacing and road marking the entrance.

In order for us to carry out these works safely we will install a two-way traffic light system on Watton Lane, outside our compound, on both Monday 7 February and Tuesday 8 February. Our temporary traffic lights will be in place from 8.00am – 5.00pm.

COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. 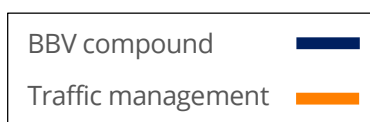
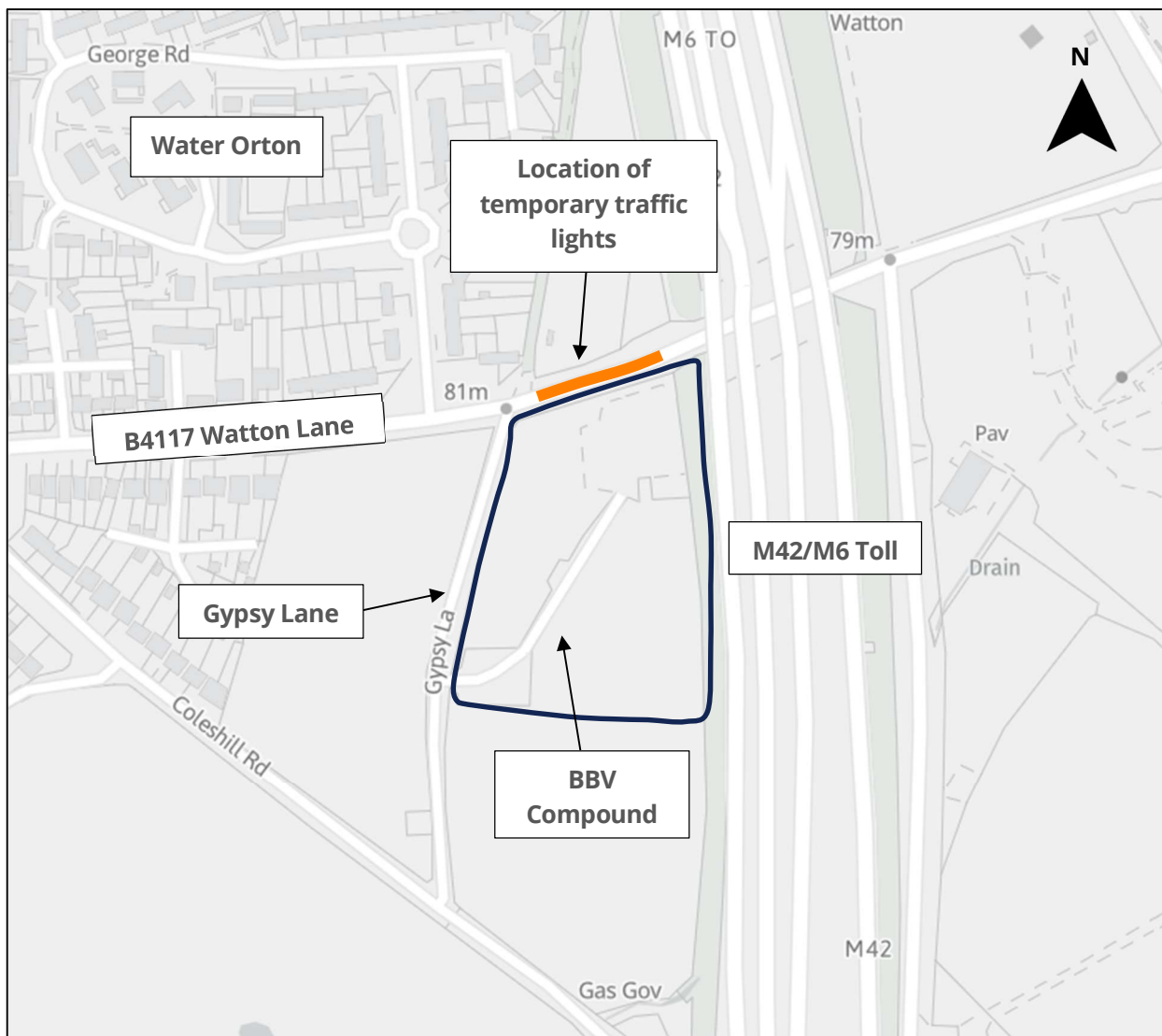
