High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## Extended working hours

To enable us to progress earthworks in your area, our working hours will be extended from Monday 2 May to Friday 30 September. From Monday to Friday, our working hours will be from 7.00am to 8.00pm and 7.00am to 4.00pm on Saturdays. We have had consent approved for these working hours. Our contractors may be on site up to an hour before and after these times to set up and close down our sites. There may be times where we are not working for the duration of these working hours. **The location of the areas we could be working in throughout the summer are outlined in the map on page 2.**

All the other works in the area will still be subject to our core working hours which are 8.00am – 6.00pm on weekdays and 8.00am – 1.00pm on Saturdays.

## HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

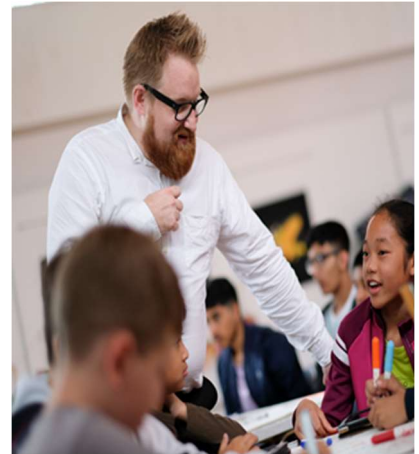
## About our Community and Business Funds
