



# Notice of traffic management on A446 and Watton Lane, near Coleshill

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we will be completing

**These works are subject to consents.** To continue to prepare for the construction of the railway, BBV will complete utility trial holes in areas of the A446 and Watton Lane from Monday 4 July until Saturday 16 July.

In order for us to carry out the works on the A446 and Watton Lane safely, we will firstly install a temporary traffic light system from Monday 4 July until Friday 8 July. (**Location shown on map on page 2**). This traffic management will be in place 24 hours a day and our working hours will be from 8.00am until 6.00pm. We will manually operate these lights from 7.00am until 7.00pm each day.

Following this, we will install a single lane closure southbound on a section of the A446 from Monday 11 July until Saturday 16 July. (**Location shown on map on page 2**). The lane closure will be in place 24 hours a day, but no traffic lights will be needed. Our working hours will be from 8.00am until 6.00pm from Monday to Friday and from 8.00am until 1.00pm on Saturday.

Our workforce may be on site one hour before and one hour after, to set up and take down equipment

## COVID-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

- Lane closure in place from 11 July until 16 July. Our working hours will be 8.00am until 6.00pm

- Our workforce to be on site one hour before and one hour after, to set up and take down equipment

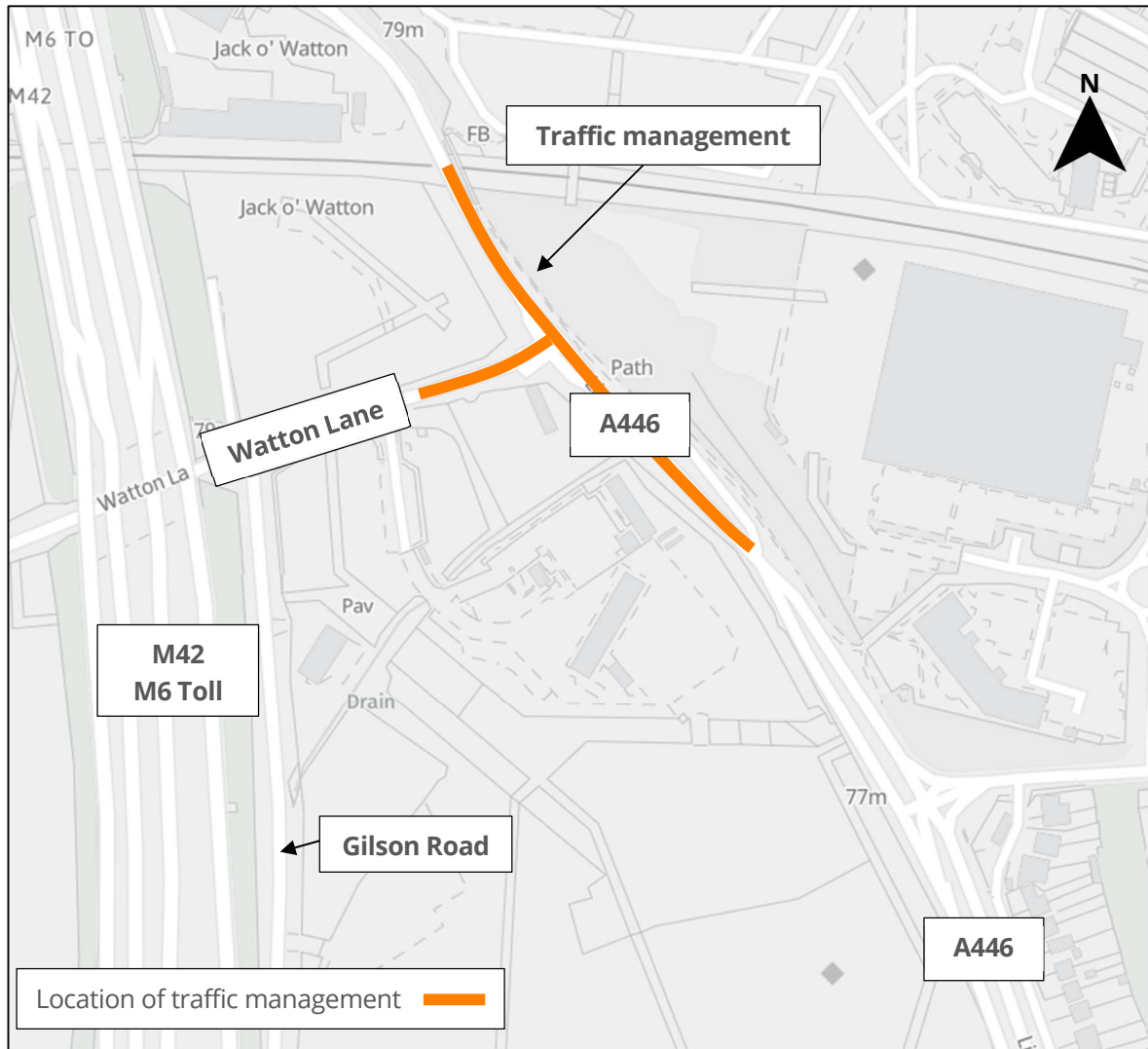
