High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

We will be completing ground investigation works on Attleboro Lane on Monday 1 August 2022. **There are four locations where the works will be undertaken, this is indicatively outlined on the map on page 2.** In order for us to complete these works safely, we will install a temporary closure throughout the works. **The location of the closure is outlined on the map on page 2.**

Access for residents and pedestrians will be maintained throughout. The closure will be in place from 9.30am until 3.30pm but our workforce may be on site one hour before or one hour after to set up and take down equipment.

HS2 during the COVID-19 pandemic

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. 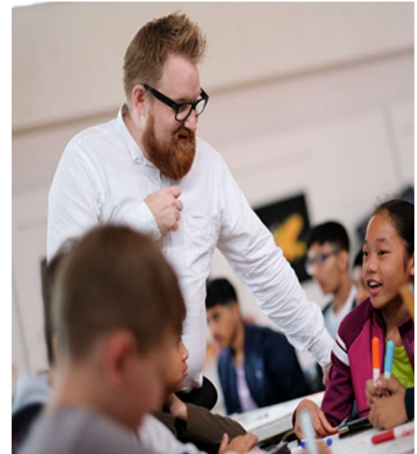
About our Community and Business Funds
