S23/19. Future Activity: To consider actions and prioritisation of future activities for the steering committee (**Appendix 4**)

It was noted that the initial convening of the committee had been delayed by absence of a full council meeting in November and the subsequent failure to call a EGM in line with procedures. This has had the predicted impact on the work of the committee.

The Steerings Committee suggested it would deal with any direct matters allocated to it by full council otherwise would restrict its activities to drawing up a schedule of review for the new membership after the elections.

Consideration was also given to whether the Steering Committee was the right structure or whether it should be a working group with greater flexibility. It was felt that it was important at its investiture that the committee had equal status to other council bodies to illustrate the importance of governance. Consideration should be given alongside other structures following the elections in May.

S23/20. Stakeholder Engagement: To further consider scope and content of Parish Survey.
