<p>Background Information:</p> <p>Insert as much information as possible so that councillors have the detail, they need to make an informed decision e.g., cost, time, long term/short term project, where, how, when why??</p>	<p>The land on Plank Lane was presented to the council along with a sum of £20,000 in exchange for support enabling the declassification of Village Green Status on the land by the Dog Inn.</p> <p>There have been communications from residents who were under the impression that the land was to be developed for use by the community. Suggestions were that it were to be used as a mindfulness space.</p> <p>Similar suggestions were made for the development of diocese owned land to the north of the new school site.</p> <p>No resolution of the council has been made in relation to this site in at least the past 3 years.</p> <p>In the absence of any firm plans the council applied for grant funding under the Kinder Food initiative to use the Plank Lane Land to enable a volunteer lead programme using the land for the purposes of growing food.</p> <p>Consideration now needs to be given to the ongoing management and maintenance of the land on Plank Lane and</p>

	<p>consideration given to other sites around the village including – but not necessarily limited to - those owned by the School, Diocese and County Council.</p> <p>This paper should be noted and informal views sought ahead of a more formal paper being brought to council over the summer of 2025.</p> <p>The neighbourhood plan contains objectives for the use and development of green spaces across the village</p>
